# **DISCIPLINARY PETITION**

# TO THE HONORABLE JUDGE OF SAID COURT:

COMES NOW Petitioner, the Commission for Lawyer Discipline, a committee of the State Bar of Texas (hereinafter called "Petitioner"), complaining of Respondent, Stanley F. Swenson, (hereinafter called "Respondent"), showing the Court:

## I.

Petitioner brings this disciplinary action pursuant to the State Bar Act, Tex. Gov't. Code Ann. §81.001, <u>et seq.</u> (Vernon 1988), the Texas Disciplinary Rules of Professional Conduct and the Texas Rules of Disciplinary Procedure. The complaint which forms the basis of the Disciplinary Petition was filed on or after May 1, 1992.

### П.

Respondent is an attorney licensed to practice law in Texas and a member of the State Bar of Texas. Respondent is a resident of and has his principal place of business in Harris County, Texas. An officer may serve citation on Respondent at 609 Fannin, Suite 326, Houston, Harris County, Texas 77002.

On or about September 11, 1985, Respondent was retained by the family members of Marva Mae Mitchell (hereinafter called "Mitchell") to pursue on their behalf, a lawsuit against Harris County, Texas, based on the alleged wrongful death of Mitchell.

#### IV.

Thereafter, various family members would periodically contact the Respondent to inquire about any progress made in the lawsuit. After several of the family members expressed frustration over Respondent's inaction, on or about May 14, 1991, Respondent scheduled a meeting with Mitchell's heirs in his office to discuss the matter. At that time, Respondent informed the heirs a lawsuit was never filed on their behalf, and that it was too late to do so given that the statute of limitations had expired. During this meeting, Respondent admitted to the heirs he had "goofed up" by not filing a lawsuit. He further offered to make some settlement to them as a result of the damage they incurred due to his failure to file a lawsuit. The Respondent, however, never followed through with the payment or an offer of any specific amount.

#### v.

Such acts and/or omissions on the part of Respondent as are described in Paragraphs III., and IV. hereinabove which occurred prior to January 1, 1990, constitute conduct violative of Rule 6-101(A)(3) of the Texas Code of Professional Responsibility. Such acts and/or omissions on the part of Respondent as are described in Paragraphs III., and IV., hereinabove which occurred on or after January 1, 1990, constitute conduct violative of Rule 1.01(b)(1) of the Texas Disciplinary Rules of Professional Conduct.

The complaint which forms the basis of the Cause of Action hereinabove set forth was brought to the attention of the Office of General Counsel of the State Bar of Texas by Minnie Holt's filing of a complaint on or about July 29, 1993.

WHEREFORE, PREMISES CONSIDERED, Petitioner prays for judgment that Respondent be disciplined as the facts shall warrant; and that Petitioner have such other relief to which entitled, including costs of Court and attorney's fees.
